Macomb HOME Consortium (MHC) Home Investment Partnership Program (HOME)

The following serves as an amendment to the County of Macomb 2016 Annual Action Plan (AAP) as per the requirements of the U.S. Department of Housing and Urban Development (HUD), 24 CFR 91.505 completed in accordance with the County of Macomb's Citizen Participation Plan.

Amendment to CDBG Planned Activities

The County is proposing to reduce the budget for CDBG Program Administration by \$25,000 and reallocate those funds for ADA improvements for the Macomb County Family Resource Center (FRC) located at 196 N. Rose, Mount Clemens, MI 48043.

The excess administration funds became available as a result of a vacant position and other program administration costs that came in lower than expected. The County is proposing to reallocate those funds to an activity to remove material and architectural barriers that restrict the mobility and accessibility of elderly or severely disabled persons to the services provided at the FRC.

Amendment to HOME Planned Activities

The County is proposing the following amendment in order to reflect a reduction to the County's 2016 HOME allocation. HOME funds were previously invested in the now defunct Solid Ground transitional housing facility. Since Solid Ground is no longer operational, the activity no longer meets the long-term affordability requirements of the HOME program. In order to clear the finding issued by the U.S. Department of Housing and Urban Development related to Solid Ground, the amount of the original investment was de-obligated from the County's 2016 HOME allocation which reduced the grant from \$1,254,669.00 to \$748,177.33.
